The 12<sup>th</sup> Meeting of the Regional Interagency Working Group on ICT 10 June 2009 at The United Nations Conference Centre (UNCC), Bangkok Thailand

#### The 15th APT Standardization Program (ASTAP) Forum

ASTAP promotes, coordinates and harmonizes telecommunication standardization activities across the Asia-Pacific region through regional cooperation.

## Date & Venue: 9 - 11 March 2009, Bangkok, Thailand Conclusions:

- The Forum approved the establishment of Ad-hoc group to study how to harmonize and integrate the works in ASTAP and Study Groups. Ad-hoc group will be chaired by Japan and assisted by Rep. of Korea and Philippines.
- The Forum agreed on proposal to modify the terms of Chairman and Vice Chairmen as two year and Chairman and Vice Chairmen may be re-nominated once when there is agreement that the work in hand would benefit from continuity.
- The Forum approved a one-day Industry workshop to be held prior to ASTAP-16 Forum in August 2009.

### The 29th APT Study Groups Meeting (SG-29)

APT Study Groups produces research and analysis based outputs that are practical, focused and relevant to the needs of the members

Date & Venue: 12 - 13 March 2009, Bangkok, Thailand (back to back with ASTAP-15)

#### **Conclusions:**

- □ The SG-29 discussed the progress of the study and approved the final reports of some of the study questions for study cycle 2008 – 2009.
- □ The meeting also approved two new study questions proposed by members.
- The meeting also discussed and decided the way forward for Study Group activities and close relationship with APT Standardization Program (ASTAP).

#### **APT Workshop on Spectrum Management and Monitoring**

Date & Venue: 30 March 2009 Danang, Vietnam Conclusion:

- □ A number of imminent speakers and spectrum experts from APT region, CEPT and CITEL delivered useful presentations at the workshop.
- The Workshop discussed key issues such as:
  - Economic and technical objectives of spectrum management
  - Traditional approaches and recent innovation to spectrum management
  - Impact of spectrum management reform
  - Best practices in managing and facilitating access to spectrum
  - Regulating spectrum trading and refarming at national level
  - Extent of spectrum harmonization in APT's perspective
  - Spectrum monitoring and compliance, monitoring data collection and technologies

### The 6<sup>th</sup> Meeting of the APT Wireless Forum (AWF)

AWF shares and discusses information of emerging radio technologies, stimulates research and development, and promotes related telecommunication business within the Asia-Pacific region.

Date & Venue: 31 March – 3 April 2009 Danang, Vietnam Conclusions:

The meeting developed:

- Questionnaires on APT Frequency Arrangements for 2300-2400 MHz and 2500-2690 MHz;
- Reports/guidelines on: Frequency Bands for Short Range Devices; Use of Mobile Phones Onboard Aircraft; and use of 406.1-430 MHz, 806-824/851-869 MHz, and 5 850-5 925 MHz bands for PPDR in some APT Countries.
- APT contributions to ITU-R Working Parties on UHF Digital Dividend activities in Asia, Frequency Arrangements for 2300-2400 MHz, Short Range Devices and PPDR.
- Liaison statements to ASTAP and APG
- The meeting also formed a Spectrum Sub Working Group on Software Defined Radio and Cognitive Radio Systems under Spectrum WG.

## **Telecommunications ICT Policy and Regulation Meeting for the Pacific**

#### Date & Venue: 29 April -1 May 2009, Nadi, Fiji

 The meeting discussed topics such as Interconnection, Regulation of Convergence of Broadcasting and Telecommunication, Innovative Broadband Networks, Pacific Islands Regulatory Resource Centre, etc.

#### **Conclusions:**

- The PIFS Taskforce decided that the Pacific Islands Resource Center is to collocate with the ITU office at PIFS.
- The meeting agreed on the formation of a working group to work on the governance, structure, and funding aspect of the Pacific Islands Resource Center with the targeted completion of the report by July 2009.
- The meeting unanimously agreed on the establishment of the Pacific region CERT (Pacific CERT).
- The meeting agreed on the formation of the working group with the members including SOPAC, ISOC, USP, PITA representatives, and Tonga who will provide feedback to ITU and AusCERT.
- The meeting agreed that the Telecommunications ICT Policy and Regulation Meeting for Pacific to be an annual event for the Pacific and held concurrently with PITA AGM.

#### First Preparatory Meetings for WTDC-10 and PP-10

APT assists its members in preparing for major global events like ITU Plenipotentiary Conference, World Telecom Development Conference (WTDC), World Radiocommunication Conference (WRC) and World Telecommunication Standardization Assembly (WTSA).

- Date & Venue: 8 May 2009 Kuala Lumpur, Malaysia (back to back with the ITU RPM for the WTDC-10)
- The meeting consolidated the regional view on common issues to be proposed to the WTDC-10 and PP-10 as common input from the Asia Pacific region.
- The meetings agreed on the working structure, work plan and expected draft results for the second preparatory meetings and nominate office bearers for the Corresponding Groups of the APT Preparatory Groups on WTDC-10 and PP-10.

#### **APT Policy and Regulatory Forum**

PRF assists members to strengthen their policy and regulatory frameworks by sharing information and experiences and providing a platform to discuss key challenges and barriers to access and other key issues.

Date & Venue: 13 - 15 May 2009 Hong Kong, SAR China Topics discussed:

- Regulatory Implications on ICT Infrastructure Development,
- Regulation in the Convergence World, IP Based Licensing,
- Destructive Elements of Communications: Security and Spam issues,
- Regulators Role in Facilitating Consumer Interest in ICT, E-commerce & E-banking, and
- Review of the key issues from the WTSA-08. Apart from these proposed topics

#### **APT Policy and Regulatory Forum**

#### **Conclusions**

- The meeting adopted the revised Working Methods APT Policy and Regulatory Forum (PRF) which will be forwarded to MC for approval. Chairman and Vice-Chairmen of the next PRF were also nominated during the meeting.
- □ The meeting agreed on the theme of the Ministerial Meeting which is "<u>Strengthen Regional Collaboration</u> towards Broadband Economy".
- The meeting agreed to establish an expert group to work on the preparation of the content of the Ministerial Meeting.
