This year PRF coincides with another important milestone in the international telecommunications community: the 150<sup>th</sup> anniversary of ITU. I am very pleased that Mr. Houlin Zhao, the Secretary-General of ITU, has sent a video message to the delegates at this Forum to commemorate this special occasion.

And what an extraordinary milestone it is: at 150 years, ITU is one of the most eminent international organisations in history and its global significance continues to grow. ITU is also one of the founders of the APT, with UNESCAP in 1979. It is our pleasure to have the opportunity at this PRF to commemorate such an auspicious occasion for ITU and I look forward to the speech by the ITU Regional Director for Asia and Pacific, Mr. Ioane Koroivuki celebrating this milestone later in the programme.

Over the next 3 days, we will have the opportunity to share experiences and ideas, to explore some of the key policy and regulatory issues in ICT today and to foster the collaboration and cooperation that will help us to move ahead together as a region.
